

We have experience of all types of dredging equipment such as submersible dredgers, trailer hopper suction dredgers and cutter-suction dredgers.

We have also assisted in the preparation of claims and counterclaims relating to delays caused by the discovery of unexploded ordnance and unforeseen ground conditions.



# Power and energy

We have acted in some of the largest energy construction projects in the world including hydroelectric power stations, nuclear power stations, wind farms and waste to energy plants.

We have particular experience in hydroelectrical power stations and the associated construction of dams across the world with clients including governments, operators and contractors in Africa, Asia, and Europe.

Our experience in the energy sector covers all stages of work. We have assisted in drafting particular conditions of contract for projects as well as acting as advocates in dispute board proceedings, arbitrations and litigation.

Whilst some of these projects had bespoke contracts, many were heavily amended FIDIC forms, including the FIDIC Yellow and Silver Books.

### Water

We have a broad range of experience in the construction of water supply and waste water treatment plants throughout Europe and Asia and have been involved in various types of claims.

Water supply projects are often large and complicated, involving many parties. They may give rise to environmental, social and economic issues as well as specialist technical issues relating to the design and/or construction and matters concerning delays. We are able to build the teams necessary to avoid and/or resolve any disputes which may arise.

We have a broad range of experience in the construction of waste water treatment plants throughout Europe and Asia and have been involved in various types of claims, from the termination of a contract for breaches of health and safety, defective work claims and the valuation of variations.

#### Our experience includes:

- Acting for an employer in SIAC arbitration proceedings under a USD60 million amended FIDIC form contract to supply a capital city with 60% of its water.
- Acting for an employer in an ICC arbitration relating to the design, supply and installation of new process plant for a facility in Europe.
- Acting for contractor in an ICC arbitration relating to a defective sewer network.
- Acting for a joint venture contractor in dispute board proceedings, and then ICC arbitration proceedings in relation to a dispute arising out of a sewerage network in Cyprus.

#### **Arbitration and litigation**

Our team act in complex, cross-border construction and engineering disputes concerning issues of delay and disruption, defects and damage claims, contract termination and disputes arising from different forms of contract, including FIDIC and other standard forms as well as bespoke contracts.

We appear as counsel and advocates in both domestic and international arbitrations including under the ICC, LCIA, SIAC and UNCITRAL rules, as well as in ad hoc arbitrations. We have also appeared before the Technology and Construction Court and the Court of Appeal of England and Wales.

Most of our lawyers have advocacy experience, some having first qualified as barristers and others holding rights of audience in the civil courts. This gives us an advantage over many other firms in that we have direct experience of how cases should be presented in the highest courts.

We have excellent working relationships with all the leading sets of construction barristers in London. However, unlike many firms, we do not simply hand over cases to barristers. We remain involved from start to finish and provide significant input into the preparation of a claim.

# Dispute boards, mediation and other forms of ADR

We provide clients with advice, representation and advocacy services in dispute board proceedings, mediations and other forms of ADR. These include Dispute Adjudication Boards (including FIDIC Adjudication Boards), Dispute Review Boards and enforcement proceedings.

We react to our clients' needs quickly and effectively, ensuring that the best possible advice is given within very tight timescales. We pride ourselves on our partner-led service but where work can be effectively prepared by an associate, it is delegated to ensure a cost-effective service.

#### Risk management and advisory

We have a wealth of experience in giving pragmatic, commercial advice to clients throughout the life of a project to prevent problems from becoming disputes. When claims are imminent, or are first presented, we advise on strategy to help limit our clients' liability and even avoid a full-blown dispute resolution procedure. We provide tactical advice on limitation issues, conditions precedent, evidence and jurisdiction, which can have a significant impact on the outcome of a dispute.

#### **Contracts**

We are experts in the FIDIC forms of contract, having been involved in the drafting of many of them. We regularly provide advice on amendments to the standard FIDIC forms of contract to suit our clients' own individual needs. We have also had experience with many of the other forms of contract including the NEC, JCT, ICE and bespoke agreements.

#### **Bonds and guarantees**

We advise employers and contractors on the drafting and enforcement of bonds and guarantees. We have acted in the enforcement of bonds and guarantees both in England and abroad and have served claims through diplomatic channels. We have also acted to prevent on-demand bonds being improperly called or paid out in various jurisdictions.
